Newsletter 64 Vaccines and Genetic Diseases

Recently there has been discussion about the genetic cause of many chronic diseases that have increased in the population in recent decades. These diseases include allergies, asthma, anaphylaxis, autism, diabetes and other neurological and autoimmune diseases: all of which have increased significantly in children after the push to increase vaccination rates in the 1990's. Whilst correlation isn't causation it needs to be investigated before the combined schedule of vaccines is recommended to the community. This study has never been done.

Chemicals in vaccines are known to switch on genes that would otherwise not be expressed. This science is called Epigenetics and in the past a family history of genetic diseases such as allergies and asthma, was considered a contraindication to vaccination (ie. vaccination was not

recommended). This is why doctors were required to assess children before a decision was made to vaccinate. This requirement was removed in the 1990's when vaccines were administered in school programs. At this time the number of vaccines on the childhood schedule increased and financial incentives were introduced to encourage doctors and parents to increase the participation rates in vaccination programs.

Whilst these diseases have a genetic cause they are not always expressed in the individual. The diseases can be switched on by environmental factors, such as the chemicals in vaccines. Children can have the gene but the condition is only expressed with exposure to certain chemicals or environmental factors. Hence the increase in chronic illness in children since the nineties can plausibly be related to the increased use of vaccines and participation in vaccination programs. This link needs to be investigated.

Influenza Vaccine (Fluad) Linked to 13 Deaths in Italy

On 28 November 2014 the Italian regulatory agency suspended 2 batches of Fluad flu vaccine after 13 people died after receiving the vaccination. However, after investigating 6 batches of the vaccine Novartis claims that 'there is no evidence that the vaccine caused these deaths'. Even though 13 people died between the 15 and 28 November after receiving flu vaccine (8 within 24 hours of receiving the vaccine) the pharmaceutical company is claiming this is just a coincidence and Novartis has claimed there is no evidence the vaccine was the cause of these deaths.

Global Concerns about HPV Vaccines in the Prevention of Cervical Cancer

Japan and India are no longer recommending the HPV vaccine in their national immunisation programs due to concerns about deaths and serious illness. Court cases have also been filed in several other countries - France, Spain, Columbia and India.

These vaccines have not been demonstrated to be <u>safe</u>, <u>effective or necessary</u> in the prevention of cervical cancer and I have provided here a <u>link to the global petition</u> calling for a moratorium on this vaccine until further safety and efficacy studies have been completed.

In other words, the pharmaceutical company was not required to provide evidence that the vaccine *did not* cause the deaths. This is the reversal of the **Precautionary Principle** that should be used in government policies to protect public health. The onus of proof of harm needs to be placed on the proponent of the activity ie. the pharmaceutical company or government regulator, in order to protect public health in government policies.

However, this principle has been reversed by governments in vaccination policies to place the onus of proof of harm on the *general public*. When the precautionary principle is used in this way it protects the interests of industry and *not the public interest* in government policy. The vaccine should be suspended until Novartis can provide evidence that the vaccine *did not cause* these deaths.
