Newsletter 107 The Australian Government's Response to my letters

On the 5 May 2016 I sent a letter to <u>A/Professor Leask</u> (government NCIRS) asking her why she is undermining the academic process with unsupported comments about my PhD thesis, instead of debating the issues. The main 'issue' being the government's removal of informed consent to vaccination and *choice* in vaccination *without coercion*, in social welfare and employment policies. To date, I have not had a reply to this letter. In my letters to Julie Leask I have asked her to provide the following information:

- 1) Her concerns about the academic process
- 2) Why she and Peter McIntyre (director of the NCIRS) and approximately 45 other health professionals/gov representatives, declined to attend a public forum to defend the new 'No Jab No Pay' legislation at the University of Technology Sydney (15 October 2015) *before this legislation was passed.*
- 3) A fully referenced copy of Peter McIntyre's comments on whooping cough published beside my referenced article on whooping cough in the PHAA newsletter (April 2009).
- 4) The reason why the PHAA immunisation conference is supporting the consumer lobby group SAVN to prevent debate of the medical literature describing the risks of vaccination.

In addition, I wrote to the president of the Australian Human Rights Commission, <u>Gillian Triggs</u>, before this legislation was passed and again I had no reply. I will provide you with the responses from these government representatives as soon as I receive them.

Please also be informed of the media blackout that exists in Australia (and many other nations) on the issue of vaccine safety and efficacy. This 8 minute video clip, Report: Ireland Fights HPV Vaccine Injury and Pharma Control made by independent journalists in Ireland, describes the blackout in the mainstream media of the dangers of the cervical cancer vaccines (HPV vaccines - Gardasil and Cervarix). This video describes the evidence of misconduct by major organisations such as the US CDC and vaccine advisory committees for the World Health Organisation (WHO) e.g. the Global Advisory Committee on Vaccine Safety (GACVS). It is also stated in this video that 10% of all girls being vaccinated with HPV vaccines are ending up in the emergency rooms of hospitals. Many Australian girls/boys have been seriously harmed by these vaccines but the Australian media will not report on these stories.
