

Dear,

I'm writing to you because of the medical discrimination that many experienced in 2021-22 due to the Australian government's directive to exclude people who chose not to have the experimental COVID19 injection.

These people were labelled 'unvaccinated' and removed from social environments and workplaces. At the tennis clubs this resulted in people being banned from the building when the bar was open.

I would like to provide you with the reasons why this discrimination was wrong and why it must never be allowed to happen again. I have copied other club members into this email because it is a club issue that needs discussing with the knowledge that people didn't have in 2021-22 when this decision was made.

Labelling a healthy person as a health risk by calling them 'unvaccinated' incorrectly assumes that they do not have natural immunity to the disease. This was a false assumption promoted by the industry that profited from the vaccine roll-out in 2020, and it is the reason that there are no grounds for medical discrimination of the so called 'unvaccinated' **ever**.

The removal of people from participating fully in society causes social anxiety and ostracism that lives on after the event, particularly when people were led to believe that it was for the '*community good*'. This has resulted in broken relationships with family and friends that have still not mended, and they cannot be healed until the truth about the COVID19 injections is exposed.

Medical Professionals are now informing the public of the dangers of COVID 'vaccines' through the [Australian Medical Professional Society \(AMPS\)](#) website. In addition, renowned UK Cardiologist, Dr. Aseem Malhotra, has just toured Australia to reveal the dangers of COVID 'vaccines', and US cardiologist, Peter McCullough toured Australia earlier in the year with the same message.

This is the reason why removing informed consent to medication in 2021-22 violated medical ethics and principles as well as the International Human Rights Covenants that Australia has ratified.
