Dear Mr. L'Estrange,

I am disappointed with [your response dated 8 March 2019](#). I note that as my local member you have not agreed to meet with me to discuss a health issue that is of serious concern to the community and that I have studied in-depth to PhD level for 15+ years.

In your letter you ignore the five questions I have requested that you ask of the Health Minister and you dismissed our concerns with the standard phrase that 'vaccines are rigorously tested' and 'safe and effective'. Your *faith* in the government's claims, without the evidence from the five questions, is noted.

You have also stated that you support 'raising the immunisation rates' of the population as if this is the same thing as improving the 'health of the population. These two things **are not the same** and this is why your constituents have asked that you answer the five questions that we have sent you before you support *mandatory* vaccination in social services policies.

No one is asking you **not to** support vaccination only that you **do not support mandatory vaccination** in exchange for education and social welfare benefits in social services policies i.e. the **No Jab No Play** policy. Did you know that doctors are paid for every child that they vaccinate and medical practices receive bonuses of thousands of dollars from the pharmaceutical companies for increasing the 'immunisation rate of under 4 year olds' in their practice?

This is called *financial coercion* in a medical procedure and this would not be necessary if the science supported mandatory vaccination - but it does not.

Please be advised that I have published your letter on my website [Vaccination Decisions](#) with the [other responses I have received from WA politicians](#) and I will be providing this information in my national and global newsletter soon. I will also provide you with the corrections to the false information that the former director of the NCIRS of 20+ years, **Peter McIntyre**, has been providing in the media about my research and qualifications since my independent research was published - '[Corrections to Peter McIntyre's false information](#)' provided in the media.

As the Shadow Health Minister you have a duty to ensure that your constituents are properly represented on this health issue. This issue is about choice in all medical interventions, including the number of vaccines we use, and any presentation of this issue as '*anti-vaccination*' is offensive and misrepresenting the community's concerns.

If our interests are not properly represented by you in the parliament then all politicians who support the implementation of the NJNPlay bill *will be held liable* for the damage this policy will cause to many children in the community.

Please note that the US has paid out \$4 billion in compensation to vaccine victims and this is believed to be only 1% of the actual damage that has occurred in the population.

Australia doesn't have a compensation system **and we do not want one** because we do not believe this damage to our children is acceptable or justified.

We will hold our politicians to account if they do not provide the evidence for the *No Jab No Play* policy that we have requested. The government's *claims* about safety and efficacy that you have paraphrased in your response to me have not been supported *with independent scientific evidence*.
