



Newsletter 192 Informed Consent to Vaccination is being Removed based on Industry Funded Studies

The Australian and US government's support for mandatory and coercive vaccination policies – a medical intervention for healthy people – is a civil or criminal offence that violates constitutional rights and bodily integrity. Yet the Turnbull government is enforcing these policies for 16 vaccines based on [industry-funded research](#).

There is no independent research on vaccines being used in government vaccination policies.

Industry-funded science is not objective science and it is being promoted by powerful industry-funded lobby groups in Australia through the media and in government vaccine advisory boards through representatives with financial conflicts of interest with industry.

Many of the 16 vaccines listed on the national program were recommended whilst Terry Nolan was the chairman of ATAGI (2005-2014) - the vaccine advisory board that makes recommendations directly to the health minister and at the same time he was deputy chair of the NHMRC - the government body that decides the direction of government funding.

Here are some of the [conflicts of interest](#) with industry that Terry Nolan had during his decade advising the federal Health Minister.

In 2007 when I requested government funding for an independent investigation into childhood health outcomes and government vaccination policies my request was rejected.

In Australia comedians and journalists are being used to stigmatise professionals and parents who have researched this topic, as 'anti-vaxxers' - as if you shouldn't discuss the risks of a medical intervention.

If the government had the science it would not be necessary to use comedians and journalists to prevent scrutiny of the medical literature by bullying.

Did you know that governments do not use improvements in children's health as the measure of the success of vaccination programs? They use *vaccination coverage* as the measure of success. They no longer [use infant mortality rates](#) because since 1995 these rates have shown that the countries using the least vaccines (Sweden and Japan) have the lowest childhood mortality (death) and morbidity (chronic illness) rates.

Sweden has also stated it will not adopt mandatory and coercive vaccination because of the serious health risks associated with vaccines and the violation of constitutional rights.

And did you know that vaccines did not reduce the [risk of infectious diseases](#) in the community? Public health reforms reduced this [risk by 1950 in Australia](#). This is why measles was not a disease to be feared and there was no vaccine in Australia until 1969 - and then it was **voluntary**.

These are myths (lies) perpetuated by governments using industry-funded science because governments are guaranteeing a market for the many vaccines that pharmaceutical companies are manufacturing. And there are [many more vaccines](#) to come and they want you vaccinated from birth to death.

Pharmaceutical companies are creating the chronic illness in the population with vaccines and then claiming they can [make a vaccine to prevent these diseases](#).

These chronic illnesses are preventable but the government is running a \$5 million propaganda campaign (an 'education' campaign would be based on objective scientific evidence) in the Australian media using comedians and journalists who are not informed of the other side of this scientific issue.

The Turnbull government has already removed people's free choice in university courses, employment, social welfare benefits and early childhood education by linking these necessities to mandatory vaccination using 16 vaccines (**no selective vaccination**).

Here is an article on the dangers of the [Hepatitis B vaccine](#) that was linked to causing multiple sclerosis (an autoimmune disease) in the early 1990's and the lack of benefit or necessity for giving this vaccine to newborn infants.

Industry is using epidemiological studies to manipulate study outcomes and to confuse the public on the cause of many of these illnesses. Doctor's are claiming the illnesses to be a 'coincidence' after vaccination and informing patients they do not know the cause of these diseases. But you will find that these chronic illnesses (in particular autoimmune diseases) have been listed on the industry package inserts for decades.

Then of course we have our federal **Health Minister, Greg Hunt**, claiming vaccines don't cause autism. This is another myth (lie) perpetuated by governments so they can continue making billions from the vaccine industry.

[Vaccines do cause autism](#) and the rate of autism is increasing exponentially each year. This is a tragedy and it is a civil offence or crime for any government to remove informed consent without coercion to medical interventions.

Australia needs comedians and journalists that will do their jobs properly and report on the public interest in this medical procedure - **the risks of vaccination**. Currently we are getting bullying and propaganda from journalists and comedians in Australia - which supports the industry's interest in these policies.
