



Newsletter 213 Australia's Health Minister, Greg Hunt, is using False Information to Mandate Vaccines

In August/September 2018 the award winning documentary, [Sacrificial Virgins](#), that describes the significant neurological damage and deaths caused by the HPV (cervical cancer) vaccine toured Australia. However the Australian government would not provide a visa for director, Joan Shenton, to tour the country with her film. Two months after this event Australia is NOW providing her with a VISA to come to Australia.

At the time, the Health Minister Greg Hunt, dismissed this film (that is being debated globally) as being '**false and reckless**' and he has participated in suppressing the scientific evidence of the risks of vaccines to the Australian public.

Greg Hunt is also falsely claiming that vaccines controlled infectious diseases. This is impossible because the vaccines were not developed in 1950 when **the risk from all infectious diseases was reduced in all developed countries** due to the improvements in public health infrastructure.

Here is a 30 minute video that was presented at the ***Vaccines and Immunisation Conference*** Osaka, Japan (23 October 2018) that describes the scientific arguments that are being ignored by Greg Hunt and other governments to claim that using multiple vaccines in infants/adults is safe. Please note that if these arguments were not fully supported by evidence the [University of Wollongong](#) and international academics would not be standing by this research. Yet the Australian media has been permitted to tell the Australian public that my research does not investigate the science of the government's vaccination policies. This is not true.

Government authorities in Australia have even been permitted to claim in the mainstream media

that this university research 'is a risk to public health' and the Universtiy of Wollongong remained silent and allowed the public to be misinformed. These actions by universities and governments are contrary to the formation of evidence-based policy.

THE POLITICS DESCRIBING HOW THIS IS HAPPENING

Health Ministers in Australia are providing information about vaccines directly from the pharmaceutical companies own research. This is why **Peter McIntyre** (ex-NCIRS Deputy /Co-Director for 20 years) and other government representatives will not debate my independent research on the government's vaccination program in any public forum.

Peter McIntyre even refused in 2017 to make his own PhD on the HIB vaccine published in 1994 available on open repository at the University of Sydney. This means his PhD is only available to university students who request it via document delivery.

This situation of health ministers presenting false health information to the public is a result of our donations and lobbying system that allows corporations to obtain access to Ministers through large donations that are not transparent to the public. This enables big pharma to feed them biased information about vaccines that they are using to design public health policies.

This has undermined the democratic process in Australia and it is putting public health at risk. But you will note that the government's spin is that "my university research on vaccines is a risk to public health". This statement is contrary to the scientific process and it is preventing the scientific evidence that is approved by a university from being scrutinised by the community of scientists and stakeholders in open public debate.

Here is the scientific-evidence that the MMR vaccine is not only linked as the most likely cause of autism and many other autoimmune and neurological disorders that are increasing in all populations, but it is ***not effective in preventing*** measles in many cases.

The outbreaks of measles are occurring in vaccinated people and until health ministers do a truly independent assessment of the risks and benefits of vaccines they must be held responsible for the harm they are causing in global populations by mandating vaccines in government policies and promoting false and misleading health information.

In 2016 the Australian government **mandated 16 vaccines** (~50 doses of vaccines) in government welfare, education and employment policies whilst at the same time removing the religious, philosophical and conscientious right of individuals to refuse a vaccine AND reducing the medical exemptions to vaccines.

This means that in Australia today there are parents whose children must be injected with all of the recommended vaccines in multiple doses - regardless of their genetic make-up - before they can access welfare benefits, many university courses and some employment situations. This represents a tragedy for human health because the government has never systematically monitored the damage that this schedule of vaccines is causing to human health.

Further the Australian media has not presented a single article in the last 2 decades that

has presented this issue as 'the public's right to choice in vaccination' even though this is stated in all international human rights covenants including the Nuremberg Code that claims all medical interventions MUST BE voluntary and without coercion.

This has occurred even though **Gilian Triggs**, the Australian Human Rights Commiissioner has been constantly informed of these scientific arguments from 2008 - 2018. The Australian Human Rights Commission is not set up to protect our individual freedoms under the international treaties that Australia is signed up to.

Please take a stand on this issue even if you are not directly affected by the mandatory vaccination policies that have already been implemented without community consultation. Be assured they will affect you one day because in 2016 the Australian government also increased the age for its vaccination policies from 7 years to 20 years thus ensuring that vaccination policies in the future can capture and discriminate against all adults as well.
