Newsletter 232 The WA Parliament tables the No Jab No Play Policy (8 May 2019) and Suppresses the Public Consultation Results

Introducing the *No Jab No Play* Policy to the Western Australian Parliament.

I would like to keep my national and global subscribers informed of current events that are occurring in the Western Australian parliament. On the 8 May 2019 the WA Health Department quietly introduced the **No Jab No Play** Bill into parliament for discussion. This was not announced in the media.

This bill removes the right of parents to decide what is injected into their children's bodies in the name of 'health' and it gives this right to the government. This is done by requiring that all children are 'fully' vaccinated in order to enrol in childcare.

Currently the Australian government is recommending 16 vaccines in its national program and it has mandated 12 of these vaccines for children 0-4 years of age to enrol in childcare. But this can be increased at any time. This is being called the '**No Jab No Play**' bill.

On the 8 May 2019 when the bill was tabled the WA parliament the community was advised that the results of its recent public consultation and regulatory impact assessment process would not be released at this time. This means that the public's questions on this policy have not been answered and the WA government has not provided a reason for its decision to go ahead with this policy.

Below is the letter that I have written on behalf of the concerned WA citizens that requests that the Health Minister, Roger Cook, provides the evidence for this policy. This needs to be done *before* this legislation is passed because human rights are being removed in this policy and the community wants transparency and accountability for this policy.

I will keep my subscribers updated as these events unfold because I know that these are global health policies and that many countries are currently removing human rights by mandating this intrusive medical intervention.

Letter and Questions to Health Minister Roger Cook from Judy Wilyman PhD

To the Honourable Minister Cook,

Re No Jab No Play Legislation

I am writing to you about the concern in the WA community regarding the **No Jab No Play** legislation that was tabled in parliament on the 8 May 2019. The Department of Health has advised the community that the results of its recent public consultation and regulatory impact assessment (Decision Regulatory Impact Statement) will not be released at this time.

This is of great concern because the community wants transparency and accountability for this health policy. It is important that the alleged justification for this legislation is properly scrutinised and discussed yet your department is not providing the results of the public consultation process to justify the need to exclude children from early childhood education if they do not receive 12+ vaccines.

This legislation will remove the right for parents to choose what they inject into their children's bodies in order for them to participate in school environments and other activities that are their right in a democratic society. This policy allows the government to decide what should be injected into our children in the name of 'health'.

I am therefore cordially inviting you to a Q and A discussion of the *No Jab No Play* policy on Parliament House steps on Thursday, May 23 at 1pm, or at another suitable time before June 4. The community has six specific questions that have not been answered to justify your decision and I will attach these questions to this letter.

This policy will remove our human right to participate fully in our democratic society without injecting 12 or more vaccines into our own and our children's bodies. Hence this policy needs extra scrutiny and accountability not suppression of the evidence that was provided in the public consultation process.

We look forward to you meeting with us to answer our questions but if this is not possible please ensure that you provide the answers to our questions in your correspondence to justify your decision to proceed with this policy.

We look forward to meeting with you and receiving the answers to our questions.

The Six Questions that the WA Health Department has not Answered to Justify the No Jab No Play Policy

In Australia we do not have any compensation scheme for the many deaths and illnesses that are being caused by vaccines.

In order for the government to claim that children who do not receive the mandated 12 vaccines are at greater risk of disease than 'fully' vaccinated children it is necessary for the WA health department to have evidence to support the following six questions:

1) The statistics for the number of vaccinated and unvaccinated children in WA per year: i) getting these 12 diseases and ii) dying of these 12 diseases?

2) Name any population/country that has used these 12 vaccines with a 95% uptake rate to control the disease?

3) Provide the statistics that show that the *overall* health of WA children (infectious diseases and chronic illness) has improved since 1990 when the vaccination program expanded.

4) i) Has the health minister been informed of the ingredients of the 12 vaccines and the serious adverse-events that are listed on the package inserts from the vaccine manufacturers ii) Please provide a link to your knowledge of the ingredients of vaccines and their side-effects.

5) i) What percentage of WA children will die or be harmed by using 12 vaccines? ii) How are the latent effects of the chemicals in the vaccines and the interaction with individual genetics being monitored in WA? ii) What adverse events (AE's) have been included in the government's risk assessment for using 12 vaccines in 0-4 year old children and what is the frequency of these AE's in this demographic of the population?

6) i) Why has the government reduced the medical exemptions to vaccination that are linked to family genetics (disease pre-disposition) that were previously contraindications to vaccination and ii) Why has the government removed our religious and conscientious freedom to choose not to use this medical intervention?

Please provide the answers to these questions to the community to justify the implementation of the **No Jab No Play** policy.
